# SPECIAL MEETING MINUTES

1. For Discussion and Possible Action to approve, approve with modifications or conditions, or deny: The 2024-2025 Fiscal Year Budget.

Deborah Connor reviewed the budget, page by page. The governmental fund (road) revenue and expenditures. The proprietary fund (water) revenue and expenditures. Fund balances reflect the revenues over expenditures over the life of the District. There are changes on Page 9, schedule B-10, Capital Outlay error in column 2 should read 59,000 rather than 168,00 and Page 17, Schedule 31 Line 3, SPB amounts (increase from 12,000 to 36,000). Recommend setting up monthly or quarterly deposits to the new LPIG fund to support the deferred maintenance such as tank dives and overcoats. Deborah also recommended we get the rest of the meters and software installed possibly through the USDA grant. Deborah also recommended the water billing system be updated, could possibly use a technology fee on the water bill for the next 5 years and use it to repay the initial cash outlay on a monthly basis from the funds collection. She may also have to explore having a hardship application for customers who qualify for such help.
